Application Request for International DCOs

Dear Sir or Madam,

It is a great pleasure for the Minsk European Games Operations Committee (MEGOC) to send out an invitation call for international Doping Control Officers (DCOs). We are happy to reach out to European NADOs and express our warmest regards.

MEGOC aims to set in place a sustainable doping control programme to deliver smooth doping control procedures during the 2nd European Games in compliance with the WADA International Standard for Testing and Investigations and the EOC Anti-Doping Rules.

In this respect, we would like to cordially invite **20** international DCOs to perform doping control duties during the Games Period **from 16 June 2019 till 1 July 2019**.

It would be most appreciated if your organization could nominate DCO candidates before **20 August 2018** to MEGOC taking into consideration the following terms:

Validity: the candidate must have a valid DCO ID;

Language skills: **fluent English is a must for all candidates**. Candidates with knowledge of Russian, German, French and Italian are highly desirable;

Availability: the candidate will have to be available for the whole period outlined above;

Recommendations: the selected candidates are required to provide a recommendation letter from an ADO that can confirm and reinforce the credibility of the selected candidates' competencies.

We plan to cover the DCO per diem (approx. 75 USD), accommodation, 1 hot meal per work day, local transportation, uniforms and AD card for the international DCOs.

Please kindly note that MEGOC does not cover transportation to and from Minsk.
